All material as listed below must be submitted with this form to The Indian Television Academy by the 30 August 2014. Programmes / Events are eligible only if their Telecast (in original form and not a repeated airing) has been in India between 1st September, 2013 and 15th August, 2014. Each form is valid for one single entry in one category only.

Photo Copies of the Entry Form can be made, but each form must be filled in original.

In order to have your programme considered, please include all the following information/material; in your submission.

- 1. The complete Entry Form (please fill out all information completely and carefully)
- 2. Still photographs from the production and in particular, the stills of the Acting Nominees with names of the Actor and Character specified.
- 3. Entry fee payment Rs. 600/-
- 4. A 50-75 word description or synopsis of the programme in Hindi or English (please attach it to the entry form)
- 5. Two Telecast Episodes of the Programme must be submitted on two DVD's (without TCR), containing both the episodes in each one of them.
- 6. Principal Cast & full production credits to be listed on a separate page and attached to the entry form.

RULES & REGULATIONS

- Submission of the programme on official Entry Form means that you have read and accepted
 the rules and regulations.
- Eligibility: Any programme originally created for TV and produced by a company in India.
- <u>Telecast of the programme</u>: the original telecast of the programme should have taken place in India between 1st September, 2013 and 15th August, 2014.
- Award Categories: As per attached list of jury awards.
- <u>Number of entries:</u> On each entry form, only one programme can be entered in one category. However, a programme can be entered in multiple categories. To do this multiple entry form can be made, but each entry form should be filled in original by the production house.
- <u>Length of entries:</u> Any programme entered in any Award category, must have a minimum format length of half hour televised slot. For interstitial/ Filler the maximum length must not exceed 15 minutes.
- <u>Co-production</u>: The entrant assumes full responsibility for notifying the other Co-producers or partners of the Entry. While all co-production partners mentioned in the entry form will be credited, only the entrant or his/her designated recipient may receive the award. In the event of protest from any of the partners, the entry will be declared ineligible.
- <u>Deadline dates</u>: the deadline for the receipt of entries along with the entry fees, entry form and programme DVD's is 30th August, 2014.
- **Programme format:** All Entries (Two telecast per category) must be submitted on one **two DVD's.** The entries should be submitted as they were initially telecasted, *without the content of the programme being re-edited.* Commercials, promos and breaks however should be removed to facilitate uninterrupted viewing by the Jurors.
- <u>Language</u>: Hindi/English / Hinglish should be the language of all the programmes entered.
- Entry Fees: The entry fee for each programme per category (i.e.) per form is **Rs. 600/-** the entry should be paid in cash or by demand draft drawn on any Indian bank and made payable to **The Indian Television Academy.**
- <u>Shipping Information:</u> Shipment cost must be prepaid by the entrant. All entries complete with form, fees, and requisite DVD's should be sent to The Indian Television Academy Award Division via Air/ Ground couriers.
- Excerpts of a maximum of 5 minutes of duration, per nominated programme may be used in any TV broadcast, Webcast and Video promotion produced for or by The Indian Television Academy.
- **Final Decision:** In the event of any dispute, the decision of The Indian television Academy Committee shall be final and binding on all concerned. DVD's accompanying the entries will not be returned. Failure to comply with the rules and regulations of the awards shall render the Entry ineligible.
- Once the top four award nominees of all the categories have been announced, and if your Show figures in the Top-4, we would require you to kindly send the Show on DG Beta / Hard Disk or DV-Cam.

Payment Information

ENTRY FEES: **Rs. 600**/- per entry per category.

Payment must be in Indian Rupees by Cash or Demand Draft drawn on any Indian Bank and made payable to "The Indian Television Academy".
